Furthermore, the petitioners alongwith 02 others filed writ petition No.2471-P/2023 in the Honr'ble Peshawar High Court with prayer to direct the respondents to upgarde the post of Assistant Programmers/Assistant LAN Administrators (BPS-16) to BPS-17 on the basis principal of parity and on the analogy of Finance department Notification dated 25.07.2019 w.e.f the same date i.e 25.07.2019 with all consequential benefits . The Hon'ble Peshawar High Court vide judgment dated 17.01.2024 disposed of the writ petition with following Directions; 'In view of the above, we ,thus considered it expedient to refer the matter of up gradation of the petitioners to up-gradation Committee of the Provincial government for its consideration in accordance with law within a period of three months" Police department in compliance of judgment dated 17.01.2024, sent the petitioners' case to Provincial government for disposal of the case vide letter No.631/Legal dated 07.02.2024. The seniority position of these three petitioners will be subject to the up-gradation Committee decision.







Out of these 83 Constable Computer Operators upgraded, 07 of them have either died or got retired leaving behind 76 Constable Computer Operators upgraded	Same 83 police constables who were working as constable Computer Operators in various branches of police were upgraded to the post of Computer Operators (BS-16) by the provincial Govt vide Notification No.SO(Budget)HD/5-20/2018 dated 11.10.2018 in violation of law/rules /policy and Apex Court judgments on the subject of absorption, out of turn promotions , Cadre change and mechanism of upgradation. 05 petitioners sought relief and upgradation on the analogy of notification ibid to the post of Computer Operators(BS-16) in Hon,ble Peshawar High Court Bannu Bench in W.P No.1109-B, 210-B, 315-B, 456-B and 786-B of 2019. The Hon,bl High Court Peshawar dismissed their petitions vide Order dated 16.12.2019. 04 petitioners again challenged the same in Apex Court by filling CPs No.481,482,89 and 622 of 2020. The Apex Court raised several questions on the upgradation of 83 police constables to post of Computer Operator (BS-16) and remitted the matter to Chief Secretary KP vide Order dated 24.1.2023 to review the whole matter after examining the law of on the subject and hearing the parties through a Speaking Order. The Chief Secretary KP authorized the Provincial Police Officer vide Letter No.SO(Police-II)HD/11-2/Court Cases/2023 dated 5.6.2023 to review the whole matter under the Law and in light of Court's observation by issuing a speaking order. The Provincial officer vide Speaking Order No.2459/Legal dated 23.06.2023 recommended Provincial Government to withdraw aforementioned Notification of upgradation being violative to law/rules /policy and Apex Court judgments. Consequently , the Provincial Government withdrew the subject Notification in respect of 76 remaining out of 83 officials vide letter No. SO(Police-II)/11-2/Court Cases/23 dated 12.07.2023. Some aggrieved constables again approached the Hon,ble High court Peshawar by filling writ petitions against the withdrawal notification ibid of Provincial Government.. The Hon,ble Peshawar High Court in writ Petitions No.2941/2023 vide order dated 14.07.2023 issued interim relief Order in respect of 76 petitioners. Therefore, the names of 76 out of total 83 police constables who were upgraded to the post of Computer Operators (BPS-16) are placed in the seniority list provisionally and conditionally subject to the final decision of the Peshawar High Court, Peshawar in the subject Writ Petitions.






