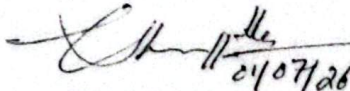

- Interested bidders must submit their bids both technical and financial through EPADS Portal. In addition, hard copies must also be submitted to the office of the undersigned.
- Bids failing to submit through both systems shall be declared non-responsive.
- The bid security (2%) shall be in the shape of CDR or any other shape acceptable under KP-PPRA Act and Rules from any scheduled bank in Pakistan in favour of the Director General Coordination Unit Khyber Pakhtunkhwa Police.
- The bidders should submit **Performance Security** as per KPPRA.
- The bidders should submit **Additional Bid Security** (if applicable) as per KPPRA Notification (Updated Rules), non submission of the same shall lead to disqualification of bidder.
- KPPRA Notification SRO (29)/Vol: I-40/2025- 26, dated 29th Oct, 2025. (**Bid Security Instrument Submission and Enforcement Regulations.2025**) shall be enforced.
- Bidders must quote rates **above or below on both MRS 2025 1st Bi-annual and Non-MRS items.**
- Bidders are advised to carry out a **site visit** to obtain first-hand information regarding site conditions before submitting their bids.
- Bids received through **hand/fax/telephone/email** will not be entertained.
- Any deficiency or deviation between hard and soft copies of the bid shall render the bid rejected and non-responsive.
- In case of any unforeseen reasons, public holidays or force majeure, the bid opening will be conducted on the next working day at the same place and time.
- Interested bidders can obtain further information / clarification from the office of **Director General Coordination Unit Khyber Pakhtunkhwa Police.**
- A **Pre-Bid Meeting** shall be held on **14th July 2026 at 2:00 PM** at the office of the undersigned.
- The procuring entity may reject all bids at any time prior to acceptance of a bid in accordance with **KPPRA Rules 47(1).**
