Whereas the First party desirous to purchase <u>Transport</u> as per description, approved specification throu transparent and fair means in the interest of the Police Department.

AND WHEREAS the Second party has the specialty in manufacturing and supply of the <u>Transport</u> registered unit under the law of Pakistan having its registered office at <u>University Road Peshawar Pakistan</u>.

AND WHEREAS the First party invited tenders for supply of <u>Transport</u> and the Second party, successful bidder has accepted the offer of the Government in lieu of the consideration mutually agreed and, terms, and condition as may be reflected in this agreement.

- 1. <u>Commencement, Duration and Extension: -</u>

3. Responsibility of the Government:-

- 3.1 Government shall place a demand for supply of <u>**Transport**</u> and shall make 100% advance paym Seller/Supplier against 100% bank guarantee.
- 3.2 Coordination with the Seller/Supplier and placing demand and payment.
- 3.3 Government will be responsible for placing the demand list to the Supplier.

4. <u>Responsibility of the Seller/Supplier:-</u>

- 4.1 Coordination with the Government in supply of the store.
- 4.2 Completion of the delivery will be as per above details.
- 4.3 Supplier will supply the store which will be inspected by the Inspection Committee of the Government. be accepted only after successful inspection by Inspection Committee of the Government. The 1 Committee may acquire the services of a suitable testing facility if so required.
- 4.4 Supplier will be responsible for removing the manufacturing fault during warranty period of 36-N 100,000 km which ever come first.
