


TENDER NOTICE

Elite Force Police Department Khyber Pakhtunkhwa invites sealed tenders based on the Khyber Pakhtunkhwa Public Procurement of Goods, Works & Services Rules 2014 from the eligible bidders/firms having previous experience as well as registered with Income Tax, Sales Tax Department as well as Khyber Pakhtunkhwa Revenue Authority for the financial year 2023-24 for the supply of Stationary Items/Articles. Tenders be addressed to the Deputy Commandant Elite Force Khyber Pakhtunkhwa Peshawar. Tenders will be opened on 11th August 2023 at 11:00 hours, in the presence of Tender Evaluation Committee and Intending Bidder in office of the Deputy Commandant Elite Force Khyber Pakhtunkhwa Peshawar. Cost of Tender is Rs.1980000/-

2. The specification/Tender documents can be obtained from the office of the Accountant Elite Force Peshawar on the submission of application on the original letter head of the firm on any working day during office hours upto 10th August 2023.

The following terms and Conditions will by apply

- i. The offers shall be accepted only with original bidding documents. Photocopies will not be accepted.
- ii. Only registered suppliers, who are on active Taxpayers list (ATL) of FBR, are eligible to supply goods/services to Government Departments.
- iii. Each firm shall submit a sample at the date of opening of Tender.
- iv. The bidders shall submit earnest money @ 2% of total cost from the account of the firm/bidder/contractor of any scheduled bank in form of Bank Draft with the financial proposals in favour of the Deputy Commandant Elite Force Khyber Pakhtunkhwa. In case of non-acceptance of tenders, the earnest money will be refunded after finalization of tender.
- v. In case of acceptance of tenders, the bidders shall deposit a security @ 10% of the total value of stores in the form of Bank Draft in the name of Deputy Commandant Elite Force Khyber Pakhtunkhwa and sign the contract agreement with Elite Force Police Department within 15-days of the issuance of the acceptance letter.
- vi. Items shall be physically inspected by Inspection Committee constituted by the Competent Authority and thereafter operationally tested. Items not found according to the standard specifications, will be rejected at the cost of Contractor and may also result in forfeiture of security or black listing of the firm etc.
- vii. Rates quoted would be considered only if the same are in Pak Rupees and inclusive of all taxes/duties/charges/and inclusive of packing/freight till delivery. Rates shall be valid upto 30.06.2024.
- viii. Conditional Tender/applications will not be entertained.
- ix. All taxes will be deducted as per the government policy.
- x. The procuring entity will have the right to reject all bids or proposals at any time prior to the acceptance of bidders proposal. The procuring entity shall upon request communicate the grounds for rejection of bid or proposal to any contractor or consultant who submitted a bid or proposal.
- xi. Supply should be completed within 03 weeks from the date of Supply order/contract agreement if the supplier failed to do so the competent authority is authorized to impose penalty on the supplier under KPPRA Rules i.e, Fine or Black Listing etc.
- xii. Samples of all toners (whether Genuine or not) shall be examined/approved by Directed I.T CPO.
