4. The bids shall reach the Office of the undersigned through registered Courier Services on or before 22/02/2024 at 11.00AM. The bids shall be opened on the same day by the Procurement committee in the presence of Representatives of the bidders who chose to attend at 11:30 AM in committee room of Office of the Addl. Inspector General of Police, Counter Terrorism Department Khyber Pakhtunkhwa, Peshawar, Pakistan. Bid submitted after due date & time shall not be entertained.

5. The bid must be accompanied with Bid Security @ 2% of the bid value in the shape of Demand Draft (DD) or Call Deposit Receipt (CDR) in the name of the undersigned.

6. The bidders shall submit an undertaking on stamp paper in their Technical Bids that the requisite Bid Security is included in their Financial Bid. Late bids will be treated as non-responsive.

7. Bids/Rates shall be quoted in PKR and on FOR basis inclusive taxes where applicable.
