

## TENDER NOTICE

Khyber Pakhtunkhwa, Police Department invite sealed tenders based on the basis Khyber Pakhtunkhwa Public Procurement of Goods, Works & Services Rules 2014 from eligible bidders/firms having previous experience as well as registered with Income Tax and Sales Tax departments for financial year 2023-24. Tenders should be addressed to the Commandant Special Security Unit (SSU) CPEC, Khyber Pakhtunkhwa Peshawar. Last date for submission of proposal is **08.09.2023** up to 1100 hrs. Technical proposals will be opened on **11-09-2023** at 1100 hrs. In the presence of Purchase committee and intending bidders in office of the Deputy Commandant SSU (CPEC) at Central Police Office (CPO) Peshawar. The delivery period will be 60-days or as per contract agreement.

### TERMS & CONDITIONS:

The following terms and conditions shall apply:-


- i. The bidders may make offers for single, multiple or all items.
- ii. The offers shall be accepted only with original bidding documents. Photocopies will not be accepted.
- iii. Only registered suppliers, who are on Active Taxpayers List (ATL) of FBR and KPRA are eligible to supply goods/services to Government departments.
- iv. Each Firm shall submit a sample on the date of opening of technical proposals.
- v. Each bid shall comprise a single sealed package containing two separate envelopes as under:-

**Technical Proposal** (Details of specifications, make, country etc. on the firm's letter head pad along with catalogue & bidding documents for respective item and submission of an affidavit on Judicial Stamp Paper that 2% Earnest money/bid security is attached with Financial Proposal).

**Financial Proposal** (Rate of respective item including all taxes/charges whatsoever as per following form on the firm's letter head pad along with 02% earnest money).

- vi. Envelops should be marked in bold letters as "**TECHNICAL PROPOSAL**" and "**FINANCIAL PROPOSAL**" respectively with name of item.
- vii. Technical proposals will be opened on **11.09.2023 at 11:00 hrs** while Financial Proposals shall remain (in sealed form) in the custody office of the Commandant SSU (CPEC) and would be opened in the presence of bidders after receipt of the technical report.
- viii. The bidders shall submit bid security from the account of the firm/bidder/contractor of any scheduled bank with their financial proposals in favor of the Commandant SSU (CPEC) Khyber Pakhtunkhwa, Police Department Peshawar. In case of non-acceptance of tenders, the earnest money will be refunded after finalization of the tender.
- ix. In case of acceptance of tenders, the successful bidder shall deposit a security @ 10% of the total value of stores in the form of call Deposit in the name of Commandant (DDO) Special Security Unit (CPEC) Khyber Pakhtunkhwa, Police Department Peshawar and sign the contract agreement with office of the Commandant SSU (CPEC) within 15-days of the issuance of the acceptance letter.
- x. The items shall be received in office of the Deputy Commandant Special Security Unit (CPEC) Peshawar. No other destination shall be acceptable. Items shall be physically inspected by Inspection Committee constituted by competent authority and thereafter operationally tested at the cost of contractor in Peshawar only. Items not found according to the standard specifications, will be rejected at the cost of contractor and may also result in forfeiture of security and black listing of the firm.
- xi. Rates quoted would be considered only if the same are in Pak Rupees and inclusive of all taxes/duties/charges and inclusive of packing charges/freight till delivery to the Commandant SSU (CPEC) CPO Peshawar. Rates shall be valid up to **30.06.2024**.
- xii. Conditional tender/application will not be entertained.
- xiii. All taxes will be deducted as per existing government policy.
- xiv. The processing entity shall have right and authority to cancel, reject or reduce/ increase the quantity of any item listed / mentioned in the instant bid / tender notice and any such decision and auction of the procuring entity shall not be challengeable in any forum/court by the bidders / participant contractors.
- xv. The procuring entity will have the right to reject all bids or proposals at any time prior to the acceptance of bidder's proposal **as per KPPRA Rules 47(1)**. The procuring entity shall upon request communicate the grounds for rejection of bid or proposal to any contractor or consultant who submitted a bid or proposal.
